## 2. Other Items not on the Agenda:

- a. Dave mentioned that he had heard of an August date for the opening of the court with the DMV to be in place in September. Chief Viola noted that files are being moved at this time and the clerks have said they will be moved in July.
- b. Dave also questioned the turning lane striping that was discussed at the previous meeting in reference to the trailer park on Nashua Street near Ponemah Hill Road. Rick told him it was on the list and had erroneously been striped to the original plan, it would be corrected. To alleviate confusion between Nashua Street westbound left turns onto the trailer park (west) driveway vs. onto Ponemah Hill Road, Jason suggested that consideration may be given to extending the center turn lane on Nashua Street along the trailer park frontage (+/-150 feet) that would then transition into the left turn lane onto Ponemah Hill Road.
- c. Gary said that he had received a letter from a Noon's Quarry Resident about the intersection with Osgood Road. The Traffic Safety Committee had looked at the area in June of 2013. Osgood Road is designated scenic and the stonewall at the intersection is privately owned adding to the difficult sight line. It was agreed after discussion to encourage the resident to contact Consolidated Communications to inquire about permission for the resident to install a mirror on the utility pole.
- d. Dave questioned the parking on High Street. The width of the road is not suitable for street parking. Captain Frye noted that Franklin Street has the same problem and the area has been problematic for a while. They are old streets and the houses have short driveways, if any at all. Few households have only one car. Dave wondered if "No On Street Parking" should be considered.
- e. Captain Frye noted that another problematic area is between the Brick house and The Elms on Elm Street. It is designated as no parking, but the signage has been missing for some time. With the increase in traffic, the area becomes bottlenecked at the West Street lights.

A motion to adjourn at 5:58 PM by Nick, Gary seconded. All were in favor.
